




Law 14010/2020

Bill 1179/2020, authored by Senator Antonio Anastasia, was signed by the President of the Republic with vetoes. LEGAL ENTITIES - GENERAL MEETINGS

Possibility of holding general meetings by electronic means, regardless of provision in the legal entity's articles of incorporation.

STATUTE OF LIMITATIONS

Prevention/suspension of statutory periods until **10/30/2020**.


Application of the rule to the statute of limitations.

CONSUMER RELATIONS

Suspension of the 7-day withdrawal rule for perishable or immediate consumption products and medicines purchased for home delivery.

ADVERSE POSSESSION

Suspension of the deadlines for the acquisition of property by adverse possession **from the moment the law enters into force and until 10/30/2020**.

COMPETITION

Ineffectiveness of articles dealing with the characterization of sale below cost price and cessation of activities of the company without cause proven as an infraction of the economic order and the classification of associative contract, consortium or joint venture as an anti-trust case, in relation to the acts performed from **03/20/2020 until 10/30/2020** or during the state of public calamity of Legislative Decree 6/2020.

Possibility of later analysis of the acts.

SUCCESSION


The 2-month period from the opening of the succession to commence the inventory and sharing proceedings for successions opened from 02/01/2020 begins on **10/30/2020**.

LGPD

Entry into force of the rules on the imposition of administrative sanctions, provided for in the General Data Protection Law (Law 13709/2018) on **08/01/2021**.

SOME OF THE MAIN VETOES:

TERMINATION, RESCISSION AND REVISION OF CONTRACTS

rules regarding the consequences of the pandemic or the non-characterization as unpredictable facts of the increase in inflation, exchange rate variation, devaluation, or replacement of the monetary standard, among others

LEASES

limitation to the granting of an injunction for eviction for actions filed as of March 20, 2020

URBAN MOBILITY

reduction of the percentage of retention by a company that operates with remunerated private vehicles transportation services, including by applications, by at least 15%, with the transfer of this amount to the driver and the impossibility of a reflex increase in prices to the user.
